Please Note: The CAAW (Confirmation of Appropriate Accommodation and Welfare) period starts 2 weeks prior to the course commencement

Guardianship Fee Structure	
Administration Fee	*A\$200
Students at primary and secondary school/foundation studies	*A\$3,000 per year
under 18 or over till they have completed their yr 12 high school	\$260.00 per month
Airport Pick up Fee (one way, covers Zone 1only) (Additional \$40 will be charged for Zone 2)	*\$130 per person per trip
Additional passengers	\$65 per person

Unless terminated in writing by either party, this Guardianship shall continue until the latter - the student turning 18 years of age, or the student completes his/her high school program (Year 12) This ongoing requirement will be communicated and directed by the individual education provider to ASE.

Refund Policy Procedure

- Any application for refund must be made in writing to ASE management by the parents stating their reasons.
- Refunds are only made in accordance with the following refund policy below.
- Any refunds will be transferred to the bank account of the original payer less transfer costs within one month (or 4 weeks) of receipt of a written application for a refund.

School Guardianship refund for under 18 or over 18 students

- a) In the event the student visa is rejected or application withdrawn, ASE will refund the total amount received as payment, less a processing fee of \$200 (Aus) and any banking fees.
- b) In the event a student arrives in Australia then withdraws or cancels their enrolment with the Education Provider or returns home, prior to commencement of study, any guardian fees paid are non refundable.
- c) There is no refund if student changes their mind and terminate guardianship after the visa is granted and the approval has been received and granted by the education provider.
- d) No refund will be made if a student is reported to Department of Home Affairs (DHA) for a breach of visa conditions and has his/her visa cancelled.

Refunds are covered by the provisions of the ESOS act 2000 and the ESOS regulations 2001 and the National Code.
