- I/We undertake to pay to all rentals, fees and any additional/incidental expenses incurred by the student and when they become due and payable. - I/We fully understand and agree that the student will be allowed to walk, ride a bike, travel by private vehicle and/or on public transport to any area unless specific written instructions are received by ASA from us, the parent/s or guardian, stating otherwise. We understand that ASA will exercise all due care and supervision to ensure the safety of the student and we will not hold ASA or its management liable or responsible for any negligence/ injuries/accidents howsoever caused.
- I/We fully understand and undertake to ensure that the student shall have adequate medical, dental and ambulance insurance covers during her residence at ASA. We hereby consent to any medical treatment deemed necessary at any time to be given to the student. We undertake to pay all medical expenses related to the student.
- I/We must take reasonable care to avoid damaging the premises.
- I/We shall keep the premises in a reasonable clean condition during the period of Agreement
